

Rules of the game “The Summer Recharge”

No purchase necessary

ARTICLE 1 – ORGANISING COMPANY

ENGIE Mobilités Electriques, hereinafter referred to as the “**Organizing Company**,” a simplified joint-stock company with a capital of €89,100,000, having its registered office at 67 rue Jules Ferry – 92250 La Garenne-Colombes, registered with the Nanterre Trade and Companies Register under number 909 073 363. Intra-Community VAT No.: FR14909073363 and BE1020493547. ENGIE Mobilités Electriques, operating under the ENGIE Vianeo brand, is organizing a free game with no purchase necessary titled “The Summer Recharge,” running from July 1, 2026, at 12:01 a.m. to August 31, 2026, at 11:59 p.m. (hereinafter referred to as the “**Game**” or the “**Promotion**”).

The purpose of these rules is to define the terms and conditions for participating in the Game (hereinafter the “**Rules**”).

ARTICLE 2 – DURATION OF THE GAME AND ACCESSIBILITY

2.1 - Duration

The Game is available on the ENGIE Vianeo app from July 1, 2026, at 12:01 a.m. through August 31, 2026, at 11:59 p.m. The Organizer reserves the right to modify or extend the Game if circumstances so require. In any event, the Organizer shall not be held liable in this regard.

2.2 - Conditions of access to the Game

Participation in the Game is open to any individual who is at least 18 years of age, a member of the ENGIE Vianeo+ loyalty program, and the holder of a valid and active email address at which they may, if necessary, be contacted for the purposes of administering the Game (hereinafter “**the Participant**”).

Only one entry per person per day is permitted for the instant win draws throughout the duration of the Game.

Participation in the Game implies that each Participant fully and unreservedly accepts these Rules in their entirety, the ethical standards in force on the Internet, as well as applicable laws, regulations (including tax laws), and other relevant provisions.

Failure to comply with the conditions of participation set forth in the Rules will result in the invalidation of the entry.

Any entry by a Participant in the Game that does not comply with the conditions set forth in the Rules, is falsified, not validated and/or not registered, or validated and/or registered after the entry deadline, or contains incomplete, inaccurate, or false information—particularly regarding identity or email address—will be considered void and will result in the immediate disqualification of the Participant in question from the Game.

In particular, the following actions may result in the Participant’s disqualification and forfeiture of their prize, at the Organizing Company’s discretion:

- any attempt at fraud, including participating under a false identity, using another person's identity, or from an address not occupied by the Participant;
- any intentional disruption of the Game.

Any participation in a form other than that provided for in the Rules will be considered void.

The Organizing Company reserves the right to conduct any necessary verification within the limits of its powers as the organizer of a game regarding the identity of Participants.

ARTICLE 3 – Rules for Participation

Participation in the Game is available exclusively through the ENGIE Vianeo app and is limited to members of the ENGIE Vianeo+ program.

No other entries submitted by any other means will be accepted by the Organizer.

To participate in the Game, Participants may, each day, from July 1, 2026, at 12:01 a.m. until August 31, 2026, at 11:59 p.m.:

- Go to the ENGIE Vianeo app;
- Create an ENGIE Vianeo+ account or log in to their account;
- Click on the Game banner to be redirected to the daily instant win page.
- Read the Game Rules;
- Launch the daily instant win game by clicking the "Play" button;
- And find out instantly whether or not they have won a discount voucher. If they win, the Participant will receive a confirmation email with the code and instructions for using the voucher.

The required contact information (last name, first name, email address) used for participation in the Promotion and, if applicable, for awarding prizes, is the information provided in the ENGIE Vianeo+ loyalty program. Each Participant is therefore asked to ensure the validity of the contact information provided.

ARTICLE 4 – PRIZES

5,000 (five thousand) prizes are up for grabs during the Game period: 5,000 (five thousand) discount vouchers worth €4 (including tax), valid only for electric vehicle charging carried out via the ENGIE Vianeo mobile app. The discount voucher will be valid for 30 days.

The prizes awarded to winners may not give rise to any dispute of any kind on the part of the winners, nor to the payment of their cash equivalent (in whole or in part), nor to an exchange or replacement for another prize, of any value whatsoever, for any reason whatsoever.

The Organizing Company reserves the right to replace the prize(s) won with a prize(s) of equivalent nature and value in the event of force majeure or if, for reasons beyond its control, the prize(s) offered are no longer available.

Prizes that cannot be distributed for reasons beyond the Organizing Company's control will be forfeited by the winners and will not be reallocated.

ARTICLE 5 – AWARDING OF PRIZES AND NOTIFICATION OF WINNERS

The instant win draws will randomly select 5,000 (five thousand) winners during the Game Period (July 1, 2026, to August 31, 2026). Each Participant may win only one prize per day, but may be selected as a winner multiple times during the Game Period.

Winners of the instant win games will receive ENGIE Vianeo discount vouchers as described in Article 4.

Winners will be notified instantly via the app screen that they have won a discount voucher. They will receive a confirmation email containing a unique discount code that they must enter into their ENGIE Vianeo+ account no later than September 7, 2026, at 11:59 PM.

ARTICLE 6 – PARTICIPATION FEES

An Internet connection is required to participate in the Promotion. The Participant is responsible for any Internet connection fees, as well as any other costs incurred in connection with participation in the Promotion.

ARTICLE 7 – LIABILITY AND RIGHTS OF THE ORGANIZING COMPANY

The Organizing Company reminds Participants of the characteristics and limitations of the Internet and disclaims all liability for any consequences arising from Participants' connection to the Internet via the Game website.

More specifically, the Organizing Company shall not be held liable for any damage, whether material or immaterial, caused to Participants, their computer equipment, or the data stored therein, nor for any consequences that may result for their personal, professional, or commercial activities.

Furthermore, the Organizing Company shall not be held liable in the event that one or more Participants are unable to connect to the website due to any technical defect or any problem related, in particular, to network congestion.

Connection to the internet and participation in the Game are the sole responsibility of the Participants.

It is the responsibility of each Participant to take all appropriate measures to protect their own data and/or software stored on their computer equipment against any infringement.

It is strictly prohibited, by any means whatsoever, to modify or attempt to modify the Game's mechanisms, particularly in order to alter the results or any element influencing the results of the prize draws.

The Organizing Company reserves the right, particularly in the event of compelling circumstances beyond its control, to extend or modify the Game at any time, in whole or in part, in the event of force majeure or fraud by any of the Participants, without the Participants being entitled to any compensation. The Organizing Company shall not be held liable for such actions.

The Organizing Company shall not be held liable if the winner cannot be reached for reasons beyond its control, particularly in the event of misdelivery of the email regarding the awarding of the prize or the inability to contact the winner due to inaccuracies in the contact information provided by the winner.

The Organizing Company shall not be held liable in the event of inaccurate or incomplete contact information, nor for misdelivery, loss, theft, or any damage to a prize occurring during its shipment or delivery.

ARTICLE 8 – PERSONAL DATA

ENGIE Vianeo, as the data controller, collects and processes the personal data you provided in the ENGIE Vianeo+ account creation form in order to allow you to participate in the Game and to facilitate its implementation, management, the selection of winners, the awarding of prizes, and the management of participants' consents.

This data is intended for the Organizing Company and its service provider, BIG MAMA Agency, which is responsible for organizing the Game. It may not be transferred to third parties.

Participants are informed that when accessing the Game

app, a functional cookie is present within it. This is a small computer file used to ensure the browsing session on the Game app. This cookie is valid only for the duration of the session, and no other cookies are used.

litigation. The Organizing Company processes data or a category of data only if it is strictly necessary for the intended purpose.

The Organizing Company processes the following categories of data:

ARTICLE 12 - GOVERNING LAW AND JURISDICTION

Participation in this Game implies unconditional acceptance of all provisions of these Rules. No responses will be provided to any inquiries regarding the interpretation or application of these Rules, the mechanics or terms of the Game, or the identity of the winners.

Except in cases of obvious errors, it is agreed that the information generated by the Organizing Company's game systems shall be conclusive in any dispute regarding connection details and the computer processing of said information relating to the Game.

Prior to any legal action related to or arising from the Rules (in particular their application or interpretation), Participants agree to seek an amicable resolution with the Organizing Company.

Any dispute that cannot be resolved amicably shall be submitted to the competent courts having jurisdiction over the Organizing Company's registered office, unless otherwise required by public policy.

In the event that any provision of these Rules is declared null and void, this shall in no way affect the validity of the Rules themselves, and all other provisions shall remain in full force and effect.

The Game is governed exclusively by French law.
